## **CONFERENCE VENUE**

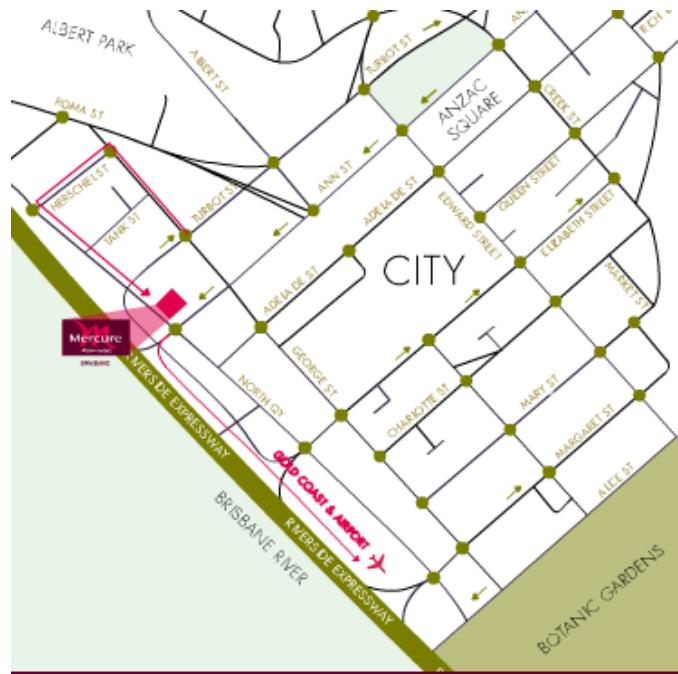

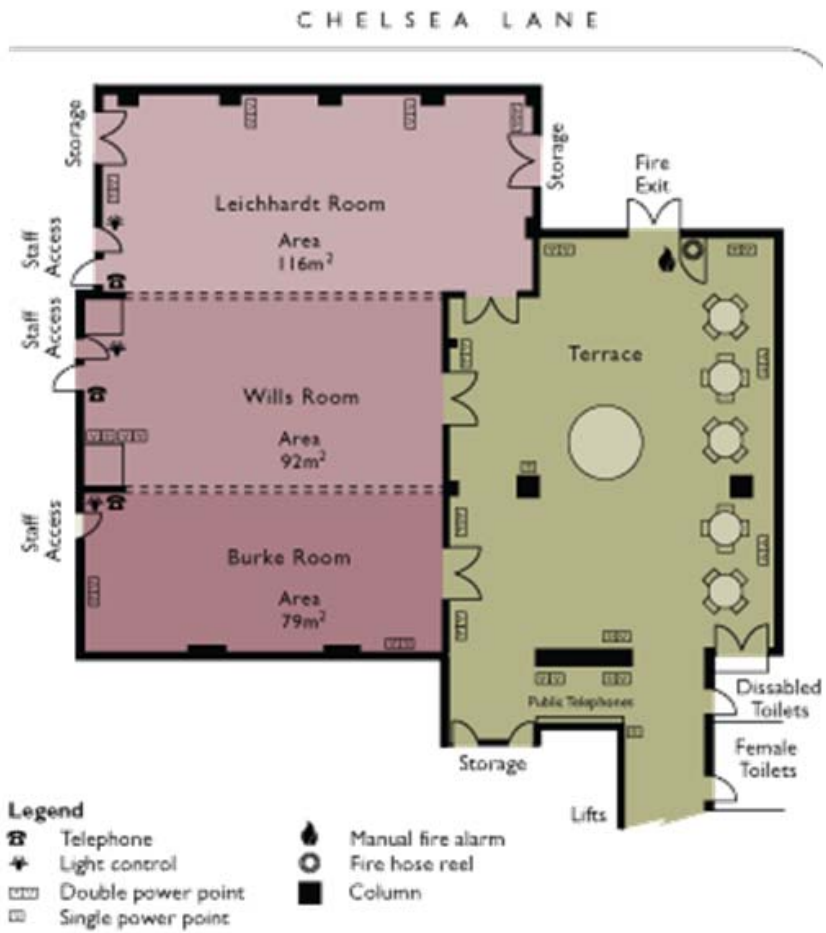
